



2023 Open Enrollment Has Begun!

The Republic Plastics and American Film & Printing Open Enrollment period begins on March 21, 2023! Open Enrollment is your opportunity to make changes to your benefits elections. The Open Enrollment period will run from **March 21** through **April 7**. Once the Open Enrollment period has ended your choices will be final until the next enrollment period or until you have a qualifying life event. All changes and elections will take effect on **May 1st**. All associates must go online and complete Open Enrollment through their UKG account before April 8.

Even if you are not making changes to your benefit elections, we need you to go into UKG and: a) verify that your enrollments are correct; and b) add or update your beneficiary information for the \$15,000 company provided life insurance. If you do not change anything, your current elections will carry over to the new plan year.

Most of our benefit offerings have not changed substantively for the 2023-2024 plan year. Summary of Benefits Changes for 2023-2024

Medical

- Because of the smart choices and care you all have taken in using pyour medical benefits, our plan saw significant savings during the 2022-2023 plan year. As such, we are passing on those savings to you through a 25% credit to your monthly premiums. See Appendix A for the new monthly premiums and the per-check amounts.
- We have added virtual primary care to our First Stop Health along with their virtual urgent care and virtual mental health services. If you are enrolled in one of our medical plans, you can now use First Stop Health to schedule and receive primary care virtually via video or over the phone.

Dental and Vision

- We are changing our carrier for Dental and Vision from MetLife to Sun Life. The coverages will remain unchanged, but Sun Life offers a much better user experience for both you and your dental/vision providers. In addition, the premiums with Sun Life will be lower than they were with MetLife. See Appendix B for the new monthly Dental and Vision premiums.
- We have also added an Employe + Child(ren) option for dental coverage. This will allow employees who want or need to cover their children to do so without including their spouse in the coverage (e.g., if a spouse has their own dental coverage).





Long Term Disability

• MetLife has increased the premium for Long Term Disability from \$0.37/\$100 of monthly salary to \$0.47/\$100.

Other Benefits

All other benefits remain unchanged.

Completing your Open Enrollment in UKG


To complete your Open Enrollment, you will need to log in to your UKG account **through a web browser**, **not the mobile app**. If you are logging in from a computer, simply go to nw17.ultipro.com and enter your user name and password (contact HR if you need help with this). If you are accessing from a web browser on a mobile device, you will still go to nw17.ultipro.com, but you will need to click on the View Desktop Version link **before you log in**. That will take you to the desktop version of UKG where you will be able to access your review.








From your home page, go to Open Enrollment under Jobs on the left hand side menu (if you don't see the menu, click on the three bars in the upper left corner). That will open up the Open Enrollment screen where you can click on the applicable Open Enrollment session. UKG will then walk you through the steps of making your benefit elections.
