Republic Plastics, LTD. has committed itself to pay certain Medical claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Fidelity Security Life and Metropolitan Life Insurance Company to pay certain Health, Dental, Vision, Life insurance, Temporary disability, Long-term disability, and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending 04/30/2022 were \$299,443.
